

FLASH Adoption Release and Indemnity Agreement

IN CONSIDERATION of the payment, of the sum of (\$_____) Dollars, cash _____ check _____ the receipt of which is hereby acknowledged, the undersigned Adopter(s) hereby forever release, discharge and covenant to hold harmless Golden Retriever Rescue and Community Education, Inc. (hereafter FLASH), and any other person, firm, or corporation charged or chargeable with responsibility or liability, their heirs, administrators, executors, successors and assigns, from any and all claims, damages, costs, expenses, loss of services, actions and causes of action belonging to the said adopter(s) arising out of any act or occurrence for the present time, and particularly on account of the adoption of the dog known as: _____

To procure the payment of said sum the adopter(s) hereby declare(s) that no representation about the nature of said dog, or any representation regarding the nature and extent of liability or financial responsibility have induced the adopter(s) to make the release and indemnity agreement.

The undersigned hereby further agrees to abide by the "terms of adoption" listed below:

Please initial each statement.

_____ Return policy, if for any reason the adoption is not satisfactory to the adopting party, or if the Adopter(s) fail(s) to comply with the terms specified in this agreement, or if any misrepresentations have been made by the adopter(s) during the life of the dog it **must be returned to FLASH**. Transfer of ownership of the "Rescue Dog" to any other person, firm, corporation, or organization is strictly prohibited.

_____ Refund Policy, this agreement has a two-week recision period during which you will receive a full refund. After that period any refund will be at the discretion of the board of directors. The request must be in writing and forwarded to the Secretary of FLASH. If the return is for medical reasons it must be accompanied by a doctor's statement of facts.

_____ The "Rescue Dog" must not be maintained as a yard dog. The primary and only function of a "Rescue Dog" is that of a house pet. I will not allow this dog to run at large.

_____ The "Rescue Dog" is to be placed on a program of inoculations and heartworm preventative as established by the adopter(s) veterinarian to guarantee the health of the dog. I understand that heartworm can be fatal to the dog if it is contracted. Rabies vaccine and license are required by state law.

_____ FLASH reserves the right to follow through on this adoption in order to protect the welfare of the "Rescue Dog". If these terms and conditions are not upheld, and/or if any misrepresentation has been made to FLASH by the said Adopter(s), FLASH reserves the right to terminate this Agreement, and the adopting party must return the "Rescue Dog" to FLASH. These rights are enforceable in the law and equity.

_____ Should it become necessary for FLASH to take legal action to recover an adopted dog or otherwise enforce the provision of the Agreement, the Undersigned Adopter(s) agree to pay all court costs and reasonable attorney's fees.

_____ I/We understand that FLASH is here to assist you with your adoption. No question is too trivial—we are here for the life of the dog.

_____ The UNDERSIGNED understands that the parties hereby released admit no liability of any kind by reason of the Adoption and that they have read the conditions of the Agreement and promise to keep the Golden as a member of their family and abide by the conditions of the Agreement.
